2019 Action on Behalf of Children Awards

Nomination Category Descriptions:

- **CHILD CARE PROVIDER / CENTER:** *The category recognizes exemplary individuals and businesses who provide early childhood care and education, including Family Child Care Homes and Child Care Centers. The nomination may be for an individual or a business.*
- **CHILD ADVOCATE** *The category recognizes an exemplary individual who has advocated for children through their work, volunteerism, or both.*
- **CHILDREN'S HEALTH:** *The category recognizes exemplary efforts by a health care professional or organization whose efforts benefit the health and well-being of children.*
- **KIDS HELPING KIDS:** *The category recognizes exemplary efforts by a child/group of children whose efforts benefit other children. Nominations must be for children between the ages 8 years to 18 years of age.*
- **BUSINESS:** *The category recognizes an exemplary for-profit business who has supported the needs of children through unique and/or exemplary actions.*
- **PUBLIC AGENCY:** *The category recognizes an exemplary organization in the public sector for their work to support the needs of children and advocate on behalf of children in our region.*
- **SCHOOL:** *The category recognizes an exemplary public, private, or charter school for their work in providing quality education to the students in our county. The nomination may be for a higher learning institution.*
- **NONPROFIT ORGANIZATION:** *The category recognizes an exemplary program or project of a nonprofit organization that benefits children in our region.*

Nomination Requirements:

1. All nominations must be received with the completed Nomination Form attached.
2. Nominations may be handwritten or typed (not to exceed 1,000 words).
3. Nominations are judged on the completeness of responses.
4. **Nominations must be received by Friday, September 13th, 2019; late submissions will not be considered.**
